UG Admission Notification 2023 (Regular for Private affiliated Colleges) under (NEP) National Education Policy 2020 for Under-Graduate 1st - 2nd Semester Batch 2023

It is notified for information of all the concerned students who have appeared / not appeared in CUET-UG- 2023 that the On-line Application forms for admission to the 1st & 2nd Semester Bachelors programme with major in Marketing Management / Financial Management/ Human Resource Management / Supply Chain Management, Bachelors programme with Major in Information Technology, Bachelors programme with Major in Computer Applications, Bachelors programme with Major in Mass Communication & Multimedia Production, Bachelors programme with Major in Accounting and taxation / Finance / Management under National Education Policy (NEP 2020) in the Private Affiliated colleges of University of Kashmir shall be available on the University official website:www.kashmiruniversity.net w.e.f. 18.08.2023 to 28.08.2023.

Eligibility Criteria for the Courses is as under:-

- Bachelors programme with major in Marketing Management / Financial Management / Human Resource Management / Supply Chain Management:**
The candidates who have passed their 10+2 class examination or equivalent shall be eligible for admission to the programme.
For CUET candidates Test Domain (Business Studies / General Test)
- Bachelors programme with Major in Information Technology:**
The candidates who have passed their 10+2 class examination or equivalent with Mathematics / Statistics / Computer Applications / Information Technology/ Information Practice shall be eligible for admission to the programme.
For CUET candidates Test Domain (Computer Applications / Information Practice)
- Bachelors programme with Major in Computer Applications:**
The candidates who have passed their 10+2 class examination or equivalent shall be eligible for admission to the programme.
For CUET candidates Test Domain (Computer Applications / Information Practice / General Test)
- Bachelors programme with Major in Mass Communication & Multimedia Production:**
The candidates who have passed their 10+2 class examination or equivalent shall be eligible for admission to the programme.
For CUET candidates Test Domain (Mass Media / Mass Communication / General Test)
- Bachelors programme with Major in Accounting and Taxation / Finance / Management:**
The candidates who have passed their 10+2 class examination or equivalent shall be eligible for admission to the programme.
For CUET candidates Test Domain (Accountancy / Book Keeping / General Test)

The main features of the programme are :-

- All Bachelor's Degree programmes are full-time regular for the specified duration as per National Education Policy (NEP-2020), with Multiple Exit and Entry options at various stages after even semesters, from the academic session 2022 and onwards.

- As per the UGC Guidelines for Multiple Entry and Exit in Academic Programmes offered in Higher Education Institutions, candidates who secure a minimum CGPA of 7.5 in a three year Bachelor's Degree Programme may be allowed to exercise the option to continue studies in the fourth year of the undergraduate programme to pursue and complete the Bachelor's Degree with Research / Honours.

For ONLINE submission of application forms, the candidates are advised to:-

- Browse the Kashmir University official website: www.kashmiruniversity.net;
- Click on the UG Regular Under Graduate (Under National Education Policy-NEP-2020) programme for private colleges, session 2023 - 24;
- Open the ONLINE form, fill it up with choice of the available Colleges in order of preference;
- Deposit the fee of Rs.500/- per Course out of which Rs.50/- chargeable as IT Fee through Online Mode (Non-refundable);
- Submit the auto-generated application form along with self attested copies with the following documents in the office of Dean College Development Council, University of Kashmir
 - CUET Score card (for candidates who have appeared in CUET)
 - Matriculation Marks Certificate;
 - Marks Card of 12th Class (Higher Secondary Part-II);
 - Domicile Certificate/Last School Attended;
 - Reserved Category Certificate (if any) issued by the competent authority;

Note:-

- The Principals of the colleges shall ensure that admission / classification is made strictly in accordance with the revised groups of subjects under NEP 2020 for the session 2023, available on University website;
- It shall be mandatory for the candidates admitted in the colleges to attend the classes regularly as their attendance for eligibility to appear in the semester end Examination shall be counted from the date of commencement of Class Work.
- The allotment of College shall be made strictly as per the preference given by the candidate in the application form.
- Candidates applying for admission to the above programme for admission must have appeared in CUET-UG-2023 conducted by NTA. The students who have not appeared in CUET-UG-2023 can also apply for admission to the above programme. However, their admission can be considered only, if any, seat remains vacant after admitting the CUET appeared candidates.
